

General

It is the responsibility of the organiser to ensure that the participants in the society behaves appropriately, have the correct standard of dress as per the code below and adhere to the tee times booked.

All players are advised to carry insurance cover for the protection of themselves and others. The golf club cannot accept any responsibility for articles lost or stolen.

Play must be from the yellow or red tees. Slow play should be avoided at all times.

Players are requested to replace all divots and repair all pitch marks. Buggies and trolleys should not be taken onto greens, tees or through bunkers. Bunkers should be raked after playing.

The organiser accepts responsibility for any damage caused by any members of his party.

The use of sponsorship signs or other advertising material is only allowed by the authorisation of the Director of Golf.

If any player fails to comply with these terms and conditions, the club may ask them to leave the course and may prohibit the player from using the facilities.

Each person playing must have their own set of clubs, NO shared clubs amongst golfers.

Dress code

On the Course (includes practice areas and putting green)

- On the Course (includes practice areas and putting green)
- Smart attire is expected at all times.
- Hats and Caps are to be worn as designed and not backwards.

Acceptable golf wear includes

- Golfing tailored trousers
- Shirts with collars. Collarless/crew neck shirts only when from a recognised golf manufacturer
- Shirts must be tucked in.
- Shorts which are tailored above the knee in length.

Unacceptable golf wear includes.

- Shirts with a longer length designed to be tucked into the waistband may not be worn over the waistband.
- Blue Denim or tracksuit bottoms
- Non tailored shorts or 3/4 length trousers for men
- Large pocket cargo shorts or trousers



- Shirts or outer garments should not be heavily embossed with logos or numbers.
- Tee shirts
- Sports Shirts (Such as football shirts, rugby shirts)
- Trainers or other non-golfing footwear

Clubhouse

• Golf shoes are not permitted in the main bar areas

Food & Drink

Only food and drink purchased from Crondon Park GC may be consumed on the premises. If food or beverages are brought for consumption, a charge will be made equal to Crondon Park's selling price for that or an equivalent product, which shall be in the absolute determination of the management. The Duty Manager may also confiscate food or beverage and return it to you on your departure.

<u>Alcohol</u>

Crondon Park operates a responsible drinking policy. In order to ensure the safety and wellbeing of our guests and staff we cannot allow guests to bring their own alcohol for consumption on the premises. We reserve the right to confiscate any alcohol brought onto the premises.

Slow Play

Slow play will detract from the day's enjoyment for all players. Golf etiquette requires you to call through players if they are being held up. Please adopt the "READY GOLF" approach to ensure there are no undue delays in the pace of play. Rounds of over four and a half hours are unacceptable. It is the organiser's responsibility to choose formats that encourage continuous play. Stableford competitions are much more enjoyable than stroke play. Our course is monitored by our Golf Professionals and team of Marshalls, should anyone be observed whose play or conduct is below acceptable level, they will be asked to keep up with the group in front, failing this they will be required to leave the course and their green fee will not be refunded.

Damage

The Client, in accepting these Terms and Conditions assumes responsibility for any and all damage caused by him or any member of his party, in any part of the Clubhouse or grounds.

Cancellation by Crondon Park Golf Club

The Club reserves the right to cancel or amend any reservations but will only do so in extreme circumstances.

Deposits

The Club requires a non-refundable deposit of 10% or £100 whichever is greater. Bookings are only confirmed once a deposit is received by written confirmation is received from the club.



Payment

Must be either cash, credit card or BACS. Payment must be made <u>IN FULL 7 DAYS PRIOR</u> to your event.

Minimum Numbers - We impose a minimum number of 12. Therefore, if your number drops below this figure, you will still be charged for 12, less your deposit paid. *CONFIRMED NUMBERS AND BALANCE IS DUE ONE WEEK BEFORE YOUR SOCIETY DAY.* This number will be the minimum charged. If you decide to cancel your booking due to inclement weather, or there being certain course conditions which you are not happy with, you will still be charged the minimum charge less your deposit paid.

Maintenance of the Golf Course

Please remember the three 'R's'

- Replace divots,
- Repair pitch marks
- Rake bunkers.

Please leave the golf course in the condition you would expect to find it!

Buggy and trolley rules

Players may use buggies and trolleys 'through the green 'but must follow all instructions, directions, and signs.

In particular players must not:

- Take buggies or trolleys on to any putting surface or tee area
- Take buggies between green side bunkers and putting surfaces
- Take trolleys or buggies into areas marked as GUR

Players with buggies or trolleys should also utilise the paths whenever possible.
